Furthermore, the reverse of the sealed envelope should bear the name and address of the bidder and dropped in the designated Tender Box at the Main Reception of ITF Headquarters Complex Building not later than **12:00 noon on Tuesday, 23<sup>rd</sup> August, 2022.**

**5. OPENING OF FINANCIAL BIDS**

The Financial Bids will be opened immediately after the deadline of submission at **12:00 noon on Tuesday, 23<sup>rd</sup> August, 2022**, in the Auditorium of ITF Headquarters Complex.

## **6. GENERAL INFORMATION**

- a) Bids must be in English language and signed by an official authorised by the bidder.
- b) Bids submitted after the deadline for submission would be returned un-opened.
- c) All cost incurred in the course of this bid will be borne by the bidders.
- d) Tenderers shall register their bids before submission.
- e) Submission of Bids sent by Post/Courier must arrive before the deadline for submission.
- f) Successful bidders will be contacted at a later date.
- g) Attendees at the bids opening shall be required to wash hands, use hand sanitiser, wear mask and observe physical distancing. The Bids Opening in the presence of observers will be covered by video recording and invitation link will be sent to bidder who chooses to join the bid opening online.
